This dual-purpose form is necessary to accurately determine financial aid awards for:

1. Students who are enrolled for courses and/or internships in any summer session term (including May Term)
2. Students who are expecting to officially graduate in August 2011 or December 2011.

Summer financial aid awards may consist of: Federal Stafford Loans, Federal Parent PLUS Loans, and Federal Pell Grants for those who are eligible as determined by the FAFSA.

Please note: Pell Grant is automatically awarded during all terms in which a student is eligible. Also, it's extremely rare that scholarships are available from any source for summer sessions.

To receive federal aid (other than Pell Grant) for summer session(s) or for any other term, the student **MUST**:

1. Be enrolled for at least six semester credit hours
2. Maintain enrollment of at least six semester hours; otherwise, federal funds may be subject to cancellation or return.

If student takes classes elsewhere for summer (or other terms), in order to be awarded federal aid at Cedarville:

1. The student must complete a Consortium Agreement. (Contact financial aid for details about this requirement.)
2. The student must also have a combined total enrollment of at least six semester credit hours from all institutions to be able to receive federal loan monies.

It is important to provide complete and accurate information on this form for each section that relates to your specific enrollment plans/situation.
