#### INSTRUCTIONS FOR STARTING YOUR CLAIM FOR VA EDUCATIONAL BENEFITS CLAIM

- 1. Visit www.gibill.va.gov to determine which educational benefit will be best for you. You may have more than one option.
- 2. **Apply for VA Educational Benefits** by completing an application on line at <a href="www.gibill.va.gov">www.gibill.va.gov</a>. Submit a copy of the application with the appropriate documentation listed below to the certifying official in the office of the registrar.
- 3. The certifying official will answer any questions you may have when you submit the initial documentation.
- 4. Apply for Admission to Cedarville University
- 5. <u>EACH SEMESTER</u> Submit a 'Veterans Enrollment Report" once your schedule is established and you can confirm no changes will be made to this schedule. A copy of the Veterans Enrollment Report can be requested from the office of the registrar during regular working hours. If you do not, your enrollment will not be certified for you to receive benefits for that term.

If you qualify for VA benefits you will begin receiving benefits <u>after</u> school begins. Eligibility is determined by the VA not Cedarville University. It is your responsibility to determine which benefit and beginning date is best for you.
